

# PRIVACY POLICY

## Privacy Policy

This Privacy Policy is for Robotics education products and services from Robotix a unit of Meritus AI Learning experiences Pvt Ltd (known as Robotix).

Robotix offers STEM, Coding, Maker Space & Robotics classes and offers for sale STEM, Robotics & Coding educational tools for children under the age of 18 for the global connected educational tools market.

Robotix is committed to protecting personally-identifiable information that we handle in the course of providing our authentication-related services ("Institution Information/Personal Information").

This Privacy Policy explains what information will be collected by Robotix ("Robotix" "we," "us," or "our") when you access our websites, software, mobile applications, connected products or related services ("Product" or "Service") and how the information will be used. We will not use or share your information with anyone except as described in this Privacy Policy. Each time you use our Service you are accepting the practices described in this Privacy Policy, as applicable, at that time.

Information Collection & Use: Robotix is the sole owner of the Personal Information collected through our Web Sites or in connection with the Services.

Data Collected from Registered Users: We need to collect Personal Information such as name, phone number, email address, state, and country in order for you to register, to ship for Products and Services or to respond to your requests for information that you may submit to us through the Web Site. We use this information to process your requests, to administer the Services and to provide information to you relating to our Services. We use this information to analyze interest in the Web Site and to improve the information we make available through the Web Sites.

You should always review, and if necessary, adjust your privacy settings on third-party websites and services before linking or connecting them to the Robotix Service or website.

User-generated content/audio/video using our mobile/laptop/tablet application is not monitored by us. For more details on our data collection practices for Children Users, please see the section on Children's Privacy.

## Cookies

Cookies are files with a small amount of data, which may include an anonymous unique identifier. Cookies are sent to your browser from a web site and transferred to your device. We use cookies to collect information in order to improve our services for you.

You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent.

The Help feature on most browsers provides information on how to accept cookies, disable cookies or to notify you when receiving a new cookie.

If you do not accept cookies, you may not be able to use some features of our Service and we recommend that you leave them turned on.

### Log Data

We may also collect information that your browser sends whenever you visit our Service ("Log Data"). We take appropriate steps to ensure that recipients of your Personal Data are bound to duties of confidentiality and we implement measures such as standard contractual clauses.

We will disclose your Personal Information where required to do so by law or if we believe that such action is necessary to comply with the law and the reasonable requests of law enforcement or to protect the security or integrity of our Service.

### Business Transaction

Your personal information may be transferred as a business asset, if Robotix is involved in a

merger, acquisition or asset sale. In such cases, we will provide notice before your Personal Information is transferred and/or becomes subject to a different Privacy Policy.

### Children's Privacy Policy

Please note that while our services & products are targeted and aimed to be used by children ( Under the age of 18 ), Only persons age 18 or older under the category of parents, legal guardians, or other adults are allowed to make purchases on our website.

Robotix makes commercially reasonable efforts to ensure its website/apps comply with the Children's Online Privacy Protection Act. Audio information is stored inside our product, and no Personal Information is collected or solicited from a child user.

Robotix does not knowingly collect information from children as defined by local law, and does not target its websites or mobile applications to children.
